Giving Patterns

As of June 30, 2019, Saint Pius X had 3,181 registered households, **58% of whom are considered givers**. 38% of the total registered families use offertory envelopes and 20% use Online Giving for their giving. The table below shows the giving information and patterns for the families registered at the parish (amounts do not include visitor/cash donations or contributions for Christmas, Easter, and Holy Days).

Financial Notes 2018-2019

- Offertory giving accounts for 88% of total parish income.
- Offertory income totaled \$2,721,732, an increase of 0.34% from the prior year, and 4% below budget.
- Parish buildings increased 50% in square footage since March 2017, from 100,349 to 156,008 square feet.
- The parish incurred a net loss of \$432,800 for the 2018-2019 fiscal year. The deficit resulted from a combination of offertory collections not meeting budget projections (\$114,487 below budget) and operating expenses plus depreciation increasing with the expansion of facilities. A similar loss of \$301,966 is projected for next year.
- Departmental expenditures remained within budget for the year.

- K-8 enrollment at the School was 534 students. The cost to educate one child is \$6,912.
- 190 students (35% of K-8 enrollment) received financial assistance, totaling \$602,411. \$365,909 in funds were received from State of Indiana School Choice scholarships (voucher program) and \$105,437 via parishioner donations to the SGO. Parish financial aid totaled \$131,065.
- The construction loan at year-end was \$2.5 million. The loan increased to \$3.5 million when construction for the project was completed (after the end of the fiscal year, fall 2019).
- Outstanding pledges at year-end were approximately \$1.2 million, 66% of which is expected to be collected.

Saint Pius Shares Program

Through Saint Pius Shares, the parish distributes $8\frac{1}{2}$ percent of the offertory to various programs, serving diverse needs outside of the parish. As part of the Diocesan Twinning Program, 5 percent is given to support Saint Adalbert Catholic School in South Bend. An additional $3\frac{1}{2}$ percent is distributed to various local, national, and international needs of the poor as recommended by the Parish Financial Resources Committee.

The long term goal is to tithe 10 percent of our collection to these and other important causes.

Frequently Asked Questions

Q: How does Saint Pius X use the money from pledged commitments to Stewardship of Sacrificial Giving?

A: Your offertory giving pays for the day-to-day operating costs of Saint Pius X. In addition, your gifts help pay for our parish's many programs, ministries and services that promote prayer and giving to others within and beyond the Saint Pius community.

Q: In what ways can gifts be designated to SPX?

A: There are many types of gifts for the parish:

- Sunday Collection (envelopes or Online Giving)
- Planned Giving
- In-Kind Gifts or Services
- Donor-specified Gifts
- Stock Gifts
- Scholarship Granting Organization (SGO)
