SUBJECT: Fiscal Year 2025 Catholic School Operating Grant Applications

Thanks to the generosity of the donors to the Annual Diocesan Appeal, I am pleased to announce that the Advancement Foundation is now accepting applications for Catholic Schools Operating Grants for FY215. Last year, \$150,000 was awarded to nine schools for learning support initiatives.

Completed grant application forms and support documentation may be submitted via email, fax or postal mail and must be received no later than **5 p.m. Monday, April 15, 2024.**

Applications will be reviewed by the Grants Committee of the Advancement Foundation. All applicants will be notified by letter prior to June 30, 2024. Grants for schools will be disbursed in ten (10) equal payments beginning in August 2024.

Please remember these criteria as you prepare your application:

- 1. Grants are for operating expenses, specifically those incurred for learning support initiatives, not for capital projects or tuition assistance.
- 2. For parochial schools, the parish shall be on track to meet its Annual Diocesan Appeal goal for FY24.
- 3. If the school has an outstanding loan, payments must be current.
- 4. The school must be current in its accounts payable.
- 5. The budget for the school for the current year and proposed budget for FY25 must accompany the grant application.
- 6. Budgets and/or cost estimates for the purposes outlined in the grant must accompany the application.
- 7. The grant application form must be completed in its entirety, including all signatures.
