

#### Benefits of Estate Planning



- Peace of Mind knowing that important and difficult decisions have been made to care for you and your loved ones.
- Provision provide for you and your loved ones.
- Protection Protect you as you age. Designate someone to carry on tasks for you and look after your care.



# Results Without Estate Planning

- Property passes via Intestate Law
- Guardianship may be necessary during your lifetime
- Your wishes may not be known and carried through
- Negative impact on your beneficiaries' lives





#### Basic Steps in Estate Planning



- Write Down What You Own
- Work With Advisors
- Know How Property is Transferred
- Complete and Execute your documents



#### Estate Planning Documents

- Last Will & Testament
- Durable Power of Attorney
- Designation of Health Care Surrogate
- Living Will
- Revocable Trust
- Will Substitutes





#### Lifetime Documents



- Durable Power of Attorney
  - Written document in which the principal, a competent adult, designates another as his or her attorney in fact (agent)
    - Can name "CO" or alternate agents
    - Effective when signed
    - Authority to handle property matters
    - Out of state document



#### Durable Power of Attorney

- Nondelegable powers
- Effective immediately unless "springing" (executed between 1/1/2002 and 9/30/11)
- Effective until principal
  - Dies
  - Revokes authority
  - Determined incapacitated and Court revokes authority





# Durable Power of Attorney



- Applies to any interest in property of principal
- Specific inclusion of homestead
- Inclusion of health care surrogate provision
- Expressly authorized powers



#### Durable Power of Attorney

- Unauthorized acts
  - Perform contractual personal services
  - Make affidavit as to personal knowledge
  - Vote in public election
  - Act in principal's place as trustee or court-appointed fiduciary
  - Execute or revoke will or codicil





# Durable Power of Attorney



- If authorized, MAY
  - Create, amend or revoke any disposition effective at principal's death
  - Transfer assets to existing trust created by the principal
  - Create trust (i.e. Medicaid QIT)
  - Gifting
  - Borrow funds
  - Access safe deposit box



#### Durable Power of Attorney

- If authorized, MAY
  - Handle tax matters
  - Change pension and insurance beneficiaries
  - Collect and make loans
  - Manage business
  - Apply for benefits
  - Make elections or disclaimers





#### Lifetime Documents

- Designation of Health Care Surrogate (Medical Power of Attorney)
  - Written document designating a surrogate to make health care decisions for the principal when he or she is determined incapacitated
    - Can name "CO" or alternate surrogates
    - Effective upon incapacity
    - Medical and end of life decisions





#### Health Care Surrogate



- Authority
- Make all health care decisions
- Consult with providers
- Make decisions as principal would have (substituted judgment)
- Make informed consent
- Access to medical records (HIPAA)



#### Health Care Surrogate

- Authority
- Apply for public benefits
- Authorize admission, discharge or transfer from facility
- Appointment of guardian does not affect authority except as Court designates
- Amendable or revocable by writing, act or orally





#### Lifetime Documents



- Living Will Declaration
  - Written declaration which directs the providing, withholding or withdrawal of life prolonging procedures in the event the principal has a terminal condition, an end-stage condition or is in a persistent vegetative state
  - Catholic living will allows the rejection of life prolonging procedures that are insufficiently beneficial or excessively burdensome.



#### Living Will

To proceed with directive it must be determined that:

- Principal does not have reasonable medical probability of recovery
- Principal falls under condition
- Any limitations or conditions expressed have been considered and satisfied





# Living Will



- Proxy
  - Judicially appointed guardian authorized to consent to end of life decisions
  - Patient's spouse
  - · Adult child
  - Parent
  - Adult sibling



# Living Will

- Proxy
  - Adult relative
    - Exhibited special care and concern
    - Maintained regular contact
    - Familiar with activities, health, religious and moral beliefs
  - Close friend





#### Wills


- Will: Document directing administration of your estate
  - Applies to solely owned property/non beneficiary designated
  - Designates beneficiaries
  - Designates Personal Representative
  - Provides for payment of debts
  - Provides for distribution of property





#### Probate Administration

- Judicial process of distribution of assets upon death
  - Required if property is in your sole name
  - Provides for a creditor's claim period
  - Court supervised administration
  - Attorney required





#### Revocable Trust



- Document directing handling of assets during lifetime and upon death
  - Successor Trustee can take over during lifetime or upon death, as needed
  - Extend benefits or protection to beneficiaries (Special Needs, Minors, Spendthrifts)
  - Avoids Probate
  - Privacy



#### Will Substitutes

- POD/TOD accounts
- Jointly held property
- Life Insurance
