2021 was a year unlike any other; with new milestones and new partnerships in philanthropy. More than \$61 million was raised by the Catholic Community Foundation to support Catholic Charities, Catholic Education, and Worship and Formation. That's a testament to YOU – your commitment, compassion, and faith-filled generosity.

The last two years have not been easy for any of us. Despite the challenges of a time defined by crisis and great need, the impact of your partnership, generosity, and friendship has been tremendous. Thank you!

The Catholic Community Foundation remains steadfast in its mission to foster faith-based stewardship in the community for the spiritual, educational, and charitable needs of all. We know when we unite with you in faith and work toward a common goal, we can help tens of thousands of people in Northeast Ohio. This Annual Report is a snapshot of what turned out to be the most impactful year in our 21-year history. The stories told here reflect our efforts together to uphold the Church of Northeast Ohio. Here are just a few highlights:

- After several record-setting years, the 2021 Catholic Charities Appeal exceeded its goal and raised \$14.5 million. St. Martin de Porres Family Center sought out neighborhood seniors who were isolated at home during the pandemic, and delivered healthy meals to their doors. Story on page 7.
- To better meet the challenges urban Catholic schools face, the Office of Education is turning to new and innovative partnerships, like the one formed with the University of Notre Dame Alliance for Catholic Education (ACE). Story on page 4.
- Many people wonder what the Church is doing to bring (and keep) young people to the faith. The diocese is not only investing in evangelization for young adults but also in 'training the trainers,' that is, our young adult leaders. Story on page 6.

• Donors are using a myriad of innovative estate planning tools to meet their unique needs and benefit their families and the Church. Andy and Karen Rebholz are no different, employing a Charitable Remainder Unitrust (CRUT) in their estate planning. Story on page 16.

We also invite you to flip over this publication to join us in celebrating the success of the Heart of a Shepherd campaign. Because of the generosity of over 13,000 donors, seminary renovations will reach completion later this year, the Priest Retirement Fund is shoring up, and our newly ordained clergy are assisted with education debt relief. In addition, parishes impacted by the economic realities of the past two years have raised funds to address capital needs at the parish level. With more than \$51.4 million pledged to the campaign, it's easy to surmise that the faithful love their parish priests and are comminited to the sacramental future of the Church.

The Catholic Community Foundation is grateful for the leadership and vision of Bishop Malesic. He continues to guide and inspire us. And we are inviting increased support through our partnership with Freewill, a will-building resource. We continuously seek to be good stewards of the resources you have so generously provided.

It is a privilege to be active in God's plan for our Church, and we humbly and gratefully invite you to continue this journey of philanthropy with us.

ACE PARTNERSHIP SETS UP TWO AKRON CATHOLIC SCHOOLS FOR Success

Shrinking enrollment and economic factors that impact area urban Catholic schools are not unique to our diocese. That is why the Office of Catholic Education continues to seek vital partnerships to help local Catholic schools stay viable for the communities they serve.

Last year, the Catholic Community Foundation helped raise the necessary funds for St. Anthony of Padua School in Akron and St. Augustine School in Barberton to join the network of Notre Dame ACE Academies. The Alliance for Catholic Education (ACE) is currently implementing a five-year partnership with these diocesan schools that began in 2021, focusing on operational vitality, Catholic school culture, teaching, and learning.

"Our local Catholic schools are often 50 to 100 years old," says Scott Embacher, regional director, Notre Dame ACE Academies-Akron. "We help set them up for success by providing operational playbooks, so they can last another 100 years and not have to face those tougher decisions of whether to stay open."

This is not to say St. Anthony or St. Augustine schools faced imminent closure, but they weren't trending in the right direction due to many factors. There were some bright spots at both schools.

Principal Kathy Wolf arrived at St. Anthony slightly before the beginning of the ACE partnership. Her fresh ideas and energy were a welcome addition and perfectly timed to renew the school's outlook.

"Our goal as an ACE Academy is to put children on a path to college and heaven. Mr. E (as the kids call Scott) has been remarkable in the pursuit of this mission," says Kathy. "He's very inspirational in the classrooms and is a tremendous asset to our school. Without the support we've received from ACE, I believe our enrollment would've remained flat, and we wouldn't have been able to sustain new programs, including our marketing campaign."

"It's not an exaggeration to say we're saving lives. If students who are in a struggling school don't get the support they need, they can find themselves locked in the cycle of poverty – exposing our kids to dangerous circumstances," says Scott. "As long as they're in the Catholic schools with us, they're well-loved, well taken care of so we can improve their futures."

Without St. Anthony and St. Augustine, most of these students would attend local public or charter school options that do not offer the same environment, academic growth, or graduation rates.

> Kathy Wolf adds, "Our school's diversity is a blessing. We have cultures from all over the world. It brings a better sense of community. It doesn't matter what color your skin is. It doesn't matter what your parents do for a living. Our students and staff support and learn from each other."

Tiffany Evans graduated from St. Anthony and is the mother of two graduates and two current students. Besides her kids requesting Asian noodles more often, she noticed other ACE improvements made possible.

She says, "There's a renewed energy at the school. I've noticed more visibility in the community due to marketing and improved technology

St. Anthony, there were 169 students. In the first year of the ACE partnership, enrollment has risen to 196, and there's already a waiting list for several of the primary grades for next year.

The school's growth goes beyond enrollment. Student test score growth has risen to be equivalent to their suburban counterparts, which is tremendous considering all the obstacles these students overcome.

The North Hill area of Akron is home to St. Anthony School and one of the nation's largest populations of refugees from Myanmar/ Burma. Many of the students' families faced persecution in their native homelands – some were put into refugee camps in Thailand before being able to immigrate to the U.S. Here they are challenged by language and economic barriers. St. Anthony plays a vital role in the lives of these children. available to students. It means a lot to me that my children can attend the same school I did, and this excellent educational option will be here for future generations."

Diocesan superintendent Frank O'Linn sees the progress made at both schools as positive momentum. Both principals and the regional director will travel to Notre Dame this summer for further training. "Thank you to all the donors and the Foundation for helping these schools become ACE Academies," he says. "Your generosity is both helping to transform the lives of students in these schools today, and providing a valuable example for the future of Catholic schools throughout the diocese."

navigating their faith in today's complicated world. He approached his pastor, Father Anthony Suso, with the idea of a small discussion-based group. The pastor was immediately on board, and Catching Fire was born.

Joe says, "We were founded on the idea of creating saints. Our goal is to equip our members with the tools needed to better live out their authentic Catholic lives. We hope all walk out a more virtuous person than when they came in."

It started with just five or six people around a single discussion topic each week. Since Catching Fire has become part of a pod with several Parma-area parishes, the group has lived up to its name with more than 400 members, with 70 young adults attending discussions and other events each week.

Thanks in part to the support from the Catholic Community Foundation, Mike Hayes is working on repeating the success of Joe's efforts by providing leadership training for other young

You're probably familiar with the St. Catherine of Siena quote: "Be who God meant you to be and you will set the world on fire."

A *Rooted in Faith – Forward in Hope* grant, applied for and awarded in 2021, is adding fuel to the fire by supporting the growth of the new Diocesan Young Adult Ministry.

Mike Hayes, the Director of the Young Adult Ministry, helped align collaborative groups or pods. "Every parish has some amazing individuals seeking community, but few had a critical mass of young adults," says Mike. "If one parish plans an event, three people show up, that's not the fun, faithful group our young adults seek. If you put a few parishes together, things start to catch fire."

No one knows this better than Joe Vicario, the co-founder of Catching Fire *(catchingfirestc.com)* and St. Columbkille parishioner. Joe wanted to connect with more young adults adult leaders in our diocese.

"Without support from the Foundation, we wouldn't have been able to expand our ministry," Mike says. "There would be a few pockets of activity but not the groundswell, diocese-wide movement it's becoming. We're more effectively organizing the leaders and putting on high-quality events.

Wilma has lived in the Glenville neighborhood for over 18 years, and St. Martin de Porres Family Center has been an important part of her life since she moved in.

pandemic caused the Center to close its doors, Wilma had to adapt to not seeing her peers every day. "Being isolated during the pandemic was hard. It was hard to figure out what to do with my time during the day because I was so used to having a full schedule every day," says Wilma.

Even though their doors were closed, St. Martin de Porres Family Center staff knew that they could not stop their services altogether. People needed them now, more than ever before – especially when it came to food.

Wilma is grateful for the services that continued during the pandemic. St. Joseph Parish School Raises Funds for a New Digital Sign

On Tuesday, November 30, St. Joseph School in Avon Lake joined 210 Catholic organizations and ministries throughout Northeast Ohio for #weGiveCatholic, Northeast Ohio's online day of Catholic giving.

"Each year we are so grateful to our stakeholders for their participation in the amazing #weGiveCatholic fundraiser," says principal John Stipek. "This program gives us an opportunity to make a meaningful change for both our parish and school community. Over the past few years, we have been able to grow our playground, create a Collaboratory for hands-on science, and add a digital sign for the school and parish. None of this would have been possible without the generosity of our families and parishioners. #weGiveCatholic provides the avenue for this growth and change."

Their efforts paid off again in 2021 as the school raised \$25,090 in one day, which included \$250 from the Boyd Watterson matching gift, \$800 from the diocesan tuition assistance matching grant, and a \$1,000 prize for third place in the small school category. All of the funds raised were used to replace the school sign that was nearly 30 years old. Today, a new digital sign greets visitors at the school entrance on Electric Boulevard.

This was the sixth year for #weGiveCatholic, which captures the spirit of gratitude and generosity and is celebrated by the Northeast Ohio Catholic community. This 24-hour crowdfunding event elevates awareness for Catholic schools, parishes, ministries, Catholic Charities sites and programs, and other Catholic nonprofits that make a positive impact through the variety of programs and services they provide.

"I encourage others to consider this vehicle for charitable giving. As long as you are 70-1/2 years old, you can contribute a percentage of your IRA and the money will go directly to the charity. For us it is as simple as a phone call."

The Corrigans are active givers in other ways as well. They volunteer at their parish, St. Ladislas in Westlake, as Eucharistic ministers and at their food bank. Tom also runs programs at Rosary Hall and The Lantern for people dealing with substance



KAREN AND ANDY REBHOLZ ENSURE THEIR CATHOLIC legacy WITH SMART PLANNING

When you're the Chief Financial Officer of a large corporation, it's no surprise when charitable organizations come looking for your expertise and involvement. "I think I had a target on my back," says Andy Rebholz with a smile.

For nearly 23 years, he worked for TravelCenters of America (TA) at their Westlake, Ohio headquarters, becoming CFO in 2007 and CEO in 2018. He had earned his degree in accounting from Duquesne University and worked for Price Waterhouse before he and his wife Karen moved their family from Pittsburgh to Strongsville to take on Andy's new job opportunity with TA. Knowing he was a committed Catholic and a donor to Catholic Charities, it wasn't long before Andy was invited to begin a relationship with the Catholic Community Foundation.

His first volunteer role was serving on the oversight committee for the diocesan *Rooted in Faith – Forward in Hope* campaign, followed by an advisory position on the audit committee of the Foundation's Board of Directors. Within a few years, he was invited to join the Board, became the treasurer, and was recently elected vice chair.

Karen was a devoted stay-at-home mom to their three children, Lauren, Andrew, and Lindsey, and very involved with the Strongsville schools' PTA and St. John Neumann parish. With their youngest off to Ohio State University, in 2019 Karen joined the Christ Child Society of Cleveland (CCS), an organization of volunteers serving children in poverty since 1916, and has been active in CCS's ministries since.

"Charitable giving has always been important to us," says Andy. "I had the kind of job that left me very little time to give but blessed me with the ability to give back more of the treasure part of 'time, talent and treasure' to the Church and our parish, and to support Catholic education."

DISCOVERING A NEW TOOL FOR PLANNED GIVING

Andy and Karen's financial advisor brought up looking into a "charitable remainder unitrust," also known as a CRUT. It's an estate planning tool that provides income to a named beneficiary during the grantor's life and then the remainder of the trust to a charitable cause.

"For a variety of reasons, it worked well for us and may work well for others," says Andy. "We could have just donated appreciated shares of stock to charity and gotten a current year tax deduction while avoiding taxable capital gains. But we learned that another smart strategy to avoid recognizing taxable income from the gain was to transfer the appreciated shares into a trust that removes those assets from the taxable estate at death."

Their financial advisor helped them follow IRS rules for a charitable trust – and understand how the CRUT benefits both them and the charitable organization.

"Over our lifetime, we receive annual distributions from the trust while the assets continue to grow in value until we die. Then the remainder of the charitable trust is paid out to the beneficiaries we named – the Catholic Community Foundation, Catholic Charities, our parish, St. John Neumann, and the American Red Cross. You could potentially put in a quarter-million dollars, and in 40 years the remainder could be worth a similar amount to the named charities. Even after you receive distributions totaling around half a million dollars over those 40 years," explains Andy.

Andy and Karen appreciate the fact that a CRUT keeps money out of their estate by putting it into a trust, allowing them to give to a charity at a later point while seeing the assets grow tax-free. It provides them with an annual cash stream and an initial-year tax deduction – and ultimately does good for others.

WHY "GIVING CATHOLIC" IS A PRIORITY

Both Karen and Andy were educated in Catholic schools in Pennsylvania. Their families placed a high value on religion, faith, and giving back. Andy's dad played leadership roles in his parish and led by example. In retirement, Andy and Karen have enjoyed being able to serve as volunteers while also living a healthier life with less stress.

He is still amazed at the providential timing of his retirement in December 2019, just days before his mother was diagnosed with cancer. He and Karen spent January and February with his parents in Pittsburgh throughout chemo treatments, right up until his mother passed away in early March – just before the pandemic shut down the country. "Thank God I was retired and could do all that, getting that time with my mother and supporting my dad. We were literally in the funeral home when the news hit about schools closing and events being canceled due to the pandemic," Andy says. "If she had died one week later, we couldn't have had a funeral. Everything has worked out for us, moving to Ohio and in so many other ways. I am convinced that somebody up there is watching out for me, so how could I not support the work of the Church with my time and treasure."



The Catholic Community Foundation's long-term investments are held in a 60% equity/40% fixed income investment portfolio that is screened in accordance with the United States Conference of Catholic Bishops (USCCB) guidelines for Catholic socially responsible investing (guidelines at *www.usccb.org*). The Foundation places great importance on risk reduction through strategic asset allocation and style diversification. The risk vs. return potential of 60% equity/40% fixed income asset allocation is consistent with the Foundation's investment return, risk tolerance, and distribution guidelines.






